ANNUAL GENERAL MEETING

Further to the notice convening the Annual General Meeting to be held on Friday, 24th June 2022, please note the following:

- Rule 14 (i) The Executive Committee Members and the Office Bearers shall be elected at the Annual General Meeting of the Club and shall hold office until the next Annual General Meeting but shall be eligible for re-election.
- Rule 14 (ii) The outgoing Office Bearers and the Executive Committee may recommend to the members, names of five (5) members for election as Office Bearers and names of ten (10) members for election as members of the Executive Committee for the ensuing year. The recommendations of the outgoing Executive Committee shall be posted on the Notice Board of the Club at least ten (10) clear days prior to the date of the Annual General Meeting.
- Rule 14 (iii) Names of other eligible members for election as Office Bearers or as Members of the Executive Committee may be proposed and seconded in writing by a Honorary Life Member, a Life Member, an Ordinary Member or by an Outstation Member over the age of 24 years and who has had a continuous period of 07 years of voting rights. The Proposer and the Secunder at the time of proposing or seconding should be a member for a continuous period of at least ten (10) years. All nominations should be forwarded to the Honorary Secretary not less than fourteen (14) clear days prior to the Annual General Meeting. The written consent of such member shall be attached. The name of contestants together with the names of the Proposer and Secunder of each contestant and the office for which election is sought, shall be posted on the Notice Board of the Club at least ten (10) clear days prior to the date of the Annual General Meeting.

Those seeking office under Rule 14 (iii) shall send in their nominations as candidates for election on or before 12.00 noon on Friday, 10th June 2022. All members seeking election should have the following qualifications:

The President shall be an Ordinary, Outstation, Life or Senior Member of the Club for a continuous period of not less than twenty (20) years.

The Honorary Secretary / Honorary Treasurer shall be an Ordinary, Outstation, Life or Senior Member of the Club for a continuous period of not less than fifteen (15) years.

The Honorary Assistant Secretary / Honorary Assistant Treasurer shall be an Ordinary, Outstation or Life Member of the Club for a continuous period of not less than ten (10) years.

And all other members seeking office should have been Members of the Club for a period of not less than 10 years and having seven (7) years of uninterrupted voting rights in the Club. No Member shall serve as a Member of the Executive Committee unless he is over 31 years of age.

Every Life, Honorary Life, Ordinary, Outstation and Senior Member with a minimum continuous membership of three (3) years and present shall be entitled to vote.

Chairman – Mr. Pandithage :

Informed the House that Mr. W.T. Ellawala has decided to step down from the post of President. He recalled the times when Mr. Ellawala was first elected as the Honorary Treasurer in 1979 and the services he rendered to the Club up to now as the President of the Club.

He mentioned that a special Executive Committee meeting was held to felicitate Mr. Ellawala and a farewell dinner was held in his honour.

He further mentioned that Mr. Ellawala was one of the greatest Presidents he has worked with and that, although Mr. Ellawala resigns from the post of President, he will continue to render his valuable services to the Club as a Trustee.

The Executive Committee has unanimously proposed Mr. I.S. De Silva for the vacant post of President. Mr. De Silva joined the Club in January 1966 and was elected to the Executive Committee at the Annual General Meeting held in May 1978, when Sir John Kotelawala was the President, Mr. F.C. De Saram was the Honorary Secretary and Mr. Ellawala was the Honorary Treasurer. Mr. De Silva functioned as the Honorary Secretary from 1982 to 1988. Mr. De Silva is a good friend of mine, he will continue to maintain the traditions and ethics of this Club, he said.

The house unanimously approved the appointment of Mr. I.S. De Silva for the post of President of the Singhalese Sports Club.

The Chairman invited Mr. I.S. De Silva to Chair the meeting and invited the Honorary Secretary to table the names of Office Bearers for the year 2021/2022.

Honorary Secretary :

“Before I proceed to announce the names of those Members who are duly elected as Office Bearers for 2021/2022, with permission from the Chair and from the House I wish to rise to a point of order.

Today, Mr. Ellawala who has contributed so much, guiding the destiny of this Club to make it what it is today, is relinquishing his duties as President after nearly 14 years.

We have had great men as Presidents of this Club, who continue to live forever in the legacy they have left behind. One among such men will be Mr. Ellawala whose legacy will live forever with this Club.

Mr. Ellawala hails from a distinguished Kandyan family in Ratnapura. He is closely related to former Prime Minister Srimavo Bandaranaike, President J. R. Jayawardene and President Chandrika Kumaratunge.

He is a product of S. Thomas’ College Mt. Lavinia where he was Head Prefect of the College and was a recipient of the Victoria Gold Medal for the Best All Round Student.

He is a trained Economist and holds a bachelor’s degree in Economics, from the University of Ceylon. He has also been trained overseas in Strategic Business Planning.

Mr. Ellawala is a highly respected business leader and is held in high esteem within the private sector.

He holds key positions on the Boards of several major Companies.

He has been a loyal and devoted Member of the SSC for more than 50 years. He was introduced by Sir John Kotelawala then President, as Honorary Treasurer even without being a member of the Executive Committee previously. He was the Honorary Treasurer for 16 consecutive years without being contested even once.

He was elected a Vice President in 1983 and a Trustee in 2002. Mr. Ellawala was elected as the 9th President of the Singhalese Sports Club in the year 2008.

I was extremely fortunate to serve on the Executive Committee when he took over as President from

Mr. De Silva hails from a well-known distinguished family of Lawyers in Sri Lanka. He is the son of late Justice K. D. De Silva an eminent Justice of the Supreme Court. De Silva is yet another Senior Lawyer who is a Trustee & a Vice President of the Club – certainly a formidable ‘de Silva’ clan of Lawyers! His younger son Ashan De Silva is the present Secretary of our Cricket House Committee. Sri Lanka’s former High Commissioner to the UK, Shenuka Seneviratne is Mr. De Silva’s niece.

Mr. I. S. De Silva is a product of Royal College Colombo, where he played Rugby for the College. He holds a bachelor’s degree in Law from the University of Ceylon.

He joined the Club in 1966 and was elected to the Executive Committee in 1978 during the Presidency of Sir John Kotelawala. He was elected as Honorary Secretary in 1982 and served under President J. R. Jayewardane until 1988. He was elected a Vice President in 1988 and a Trustee of the Club in 2004.

Sir, you are the 10th President of the Singhalese Sports Club, and we have no doubt that you are a worthy successor to Mr. Ellawala. I warmly welcome you on behalf of the Executive Committee and look forward to working alongside in taking this esteemed Institution to the next league and wish you all success in the months and years ahead.

The President:

“I first stepped foot to this most prestigious sports Club 55 years ago.

It is probably this vision that also contributed to most of the development work that was undertaken at the Club during his stewardship. We are deeply obliged to this selfless service he has rendered to this Club, initially as a Treasurer for 16 years and as President for 13 years. Therefore, I have no doubt that the entire membership of this Club joins me whole heartedly in thanking Tommy for his yeomen service and we all wish him good health and long life and continued service to this Club.

My vision as President is to take this Club to even greater heights with the support of the Executive Committee and the House Committees and you as members. I too endorse the ethos that any successful business, profession or even the management of a Club of this nature requires discipline. It is discipline in conduct, management and accountability that is the bedrock of all success whether it is of a personal or of any other nature. It is the self-discipline that we can collectively instill as members, that can ensure that we could proudly call ourselves as members of the SSC, as I stand here and say now.

I will ensure that any audit issues raised with regard to the finances of the Club will be promptly addressed and if there is any wrongdoing such wrongdoing will be dealt with as severely as permitted. You have my assurance that I will make myself available to hear members on their suggestions to

further develop the Club and more importantly that rules of the Club are implemented across the board without fear of favour, amongst all. I am emboldened and heartened by the fact that I have an exemplary Executive Committee and an equally efficient Honorary Secretary and Honorary Treasurer that understands what this Club stands for and signifies. I am sure we as a team could take this Club to greater heights.

Before I conclude, may I also take this opportunity to highlight the fact that it is important that we consider implementing certain measures to increase patronage of members and also have a sustainable source of revenue for Club. It is through the patronage of members that the Club generates most of its revenue. The recent pandemic and closure of the Club for indefinite periods of time caused severe hardships to our staff due to lack of patronage by members. Despite the closure, the Club had certain fixed costs it had to bear such as maintenance and salaries, though the Club was not generating revenue. Therefore, it is timely that we look at certain measures that we could introduce to deal with such situations, to ensure that the welfare of the staff, and how costs of the Club could be met in such challenging times, without the Club having to draw on its reserves.

Having said that, let me conclude by extending my renewed appreciation to Tommy for his sterling service to this Club and I call upon all members of this Club to unite with the committee to preserve and further SSC to the unparalleled heights it has enjoyed over 121 years.

Finally, I call upon all of you present to be upstanding and join me in giving Tommy a much-deserved hearty round of applause as appreciation for the service he has rendered to the membership of this Club.

Thank you once again for the trust placed in me.”

At the conclusion of the speech, the President thanked the Members present and the meeting was adjourned with a vote of thanks to the Chair.

As such, the President proposed the above revision on Entrance Fees from the Chair, and it was unanimously approved by the House present.



To approve a proposed plan to construct a new Office Administration Block for the Club at an estimated cost of LKR 17,108,748/73 to be awarded to Ms. G. L. Piyadasa Builder & Contractor as recommended by Architect Mano Ponniah and To approve a further sum of Rs. 5 million for the furniture and fittings of the proposed building.

To approve to name the proposed Office Administration Block as “**Nimal Dias Jayasinha Administration Enclave**” in consideration of the generous donation to be provided by Mr. Nimal Dias Jayasinha.

To execute the project. Drawings, proposals, and cost estimates can be viewed at the Club office. The project will take approximately six months to complete from the date of commencement”

President Mr. I. S. De Silva said that he was delighted to inform the house that Mr. Nimal Dias Jayasinha Trustee, Vice President, and a former Honorary Secretary of the Club has informed the Club that he would donate a sum of Rs. 20 million towards the construction of the new Office Administration Block. The resolution was duly adopted unanimously.



REPORT OF THE EXECUTIVE COMMITTEE FOR THE YEAR 2021

Dear Fellow Members,

It is my privilege to present, on behalf of the President & the Executive Committee, the Executive Committee Report for the year ended 31 December 2021.

2021 was a year of many challenges ravaged by the Covid-19 pandemic. We have never experienced a pandemic that has lasted over two years leading to travel restrictions and countrywide lockdown. It would be an understatement to say that the Club was affected by the pandemic. The Club remained closed or partially closed for most parts of the year and had to be operated with curtailed patronage of activities, food, and beverage services until about October. The Lawn Cafe had to be closed as Tasty Caterers to whom it was outsourced pulled out due to the Club closure. The annual big matches and limited over fixtures usually held in the months of March and April did not take place. Instead, the Royal-Thomian big match was played without spectators in October and the Joe-Pete big match and the limited over game were played without spectators in December. The Annual General Meeting usually held in June had to be postponed due to health/travel restrictions and was held in July. Club activities gradually resumed in the month of July with the ease of travel restrictions but had to be curtailed again in August due to health restrictions. The Club is the extended home for members. Hence, regular antigen testing for screening staff along with other preventive measures were taken and we continued to promote 'minimize health and safety risk' as the top priority to ensure that the Club is a safer place for our members to visit and enjoy, and as a result cope better with the stress of the pandemic. To encourage members to patronize the Club, we made a conscious decision not to increase the Bar and Restaurant prices although the costs were rapidly increasing. We continued to look after our biggest asset, the staff of the Club, by ensuring their salaries, bonus payments and other entitlements were paid on time.

Due to the closure of the Club during most part of the year under review, a substantial drop in income is recorded from all activities, restaurant, and bar operations. Except for Swimming and Table Tennis, all other activities of the Club and the Bar & Restaurant have recorded a loss. Despite these setbacks, we were able to put on a resilient performance in the face of unprecedented circumstances and still managed to do well to record a marginal profit of Rs. 9M before tax and Rs.8.5M after tax due to prudent financial management and financial discipline.

At the Annual General Meeting held in July, Mr. W. T. Ellawala stepped down after 14 years of service as President of the Club. Many landmark achievements were accomplished during his years as President. He will undoubtedly remain as a legendary President of the Sinhalese Sports Club. A farewell dinner was held at the Club in his honour by the Executive Committee. Mr. I. S. De Silva, the senior-most Vice President was unanimously recommended by the Executive Committee in agreement with the Vice Presidents of the Club and was duly elected as the new President at the Annual General Meeting.

A Rules Reform Committee was appointed last year to review and revise the Club Rules. A proposal submitted by the said committee is being reviewed by the Executive Committee.

At a Special General Meeting of the Club held in November approval was granted to revise the Entrance Fee to be charged from new members.

Mahela Jayawardena brought fame to the Club and the Country by being the first SSC Cricketer to be inducted to the ICC Cricket Hall of Fame in November.

Some Notable Achievements Last Year

INFRASTRUCTURE DEVELOPMENT

The Indoor Nets were refurbished and named after late Mr. Michael De Zoysa in January.

A Bottle Bank Facility was successfully launched at the Centenary Bar in February. Initially the project was launched with 48 Bottle Banks but due to the high demand further 12 Bottle Banks were added in September. The project was undertaken and successfully completed by Wasantha De Silva, member of the Bar Committee.

The Staff Quarters were completely refurbished at a cost of Rs. 2M in July.

An Agreement was entered into with Singer Sri Lanka in July to Digitalize the Score Board.

Construction of a new Security Hut commenced at the Club Entrance in August.

The installation and commissioning of Phase 2 of the Solar Power PV System to add an additional 185KW to the National Grid was completed. The system is capable now to generate a total of 400KW of Solar Power.

Fully automated Barrier Gates were installed for the convenience of members.

SPORTS ACTIVITIES

As in the previous year, domestic Cricket and all other sports activities were curtailed during the year under review due to the health restrictions imposed by the government. The Annual SSC Open Ranking Badminton, the SSC Open Ranking Squash Championships, the Annual Swimming Gala and the Gym Night could not be held. However, the Tennis House Committee successfully conducted the SSC Open Tennis Championship, the Tennis Tens, and the International Wheel-chair Tennis Championship.

Several SSC cricketers continued to represent Sri Lanka during the year under review. Dimuth Karunaratne captained the Sri Lanka Test team whilst Dasun Shanaka captained the Sri Lanka ODI team and the T20 team. Dasun also captained the Sri Lanka T20 team at the World Cup held in Dubai. Charith Asalanka and Avishka Fernando are the other SSC Cricketers who represented the National Teams. Dimuth was selected as a member of the ICC Team of the Year.

Several SSC members continued to hold key positions in Sri Lanka Cricket.

F&B/ENTERTAINMENT

The Wednesday Hopper Nights with live Saxophone music and the different theme nights on Fridays with live Bands have become very popular with the members.

The revenue generated from the function venues of the Club was significantly reduced during the year under review due to Covid-19 restrictions impacting the overall F&B revenue.

To celebrate the 25th Anniversary of the 1996 World Cup Victory, the match was shown to members on a Giant Digital Screen under the theme “Relive The ’96 World Cup Final”.

To celebrate the Sinhala & Tamil New Year an event and a theme night titled “Avurudu Udawa” was organized by creating a traditional Sri Lankan village with traditional games for the whole family alongside a Sri Lankan Buffet.

A Christmas Market was organized at the Club with many stalls taken by members and their guests and managed by them for the benefit of the members.

A Carols Night with Yohan & Honorine, A Christmas Eve Dinner with Damian & the D Zone and a 31st Night Dinner with the popular Band ‘Annesley with Super Chimes’ was held with many members attending these events.

SPONSORSHIPS

During another difficult year the Cricket House Committee was successful in securing new sponsorships for Cricket from Daraz and Brandix and retain the sponsorship of Akbar Brothers. deliver CCTV Camera System and Wi-Fi services covering the entire Club. Sponsors have been found to upgrade the Service Bar and Restaurant area.

I wish to place on record my sincere appreciation to all the staff led by the General Manager Chari Vithanachchi & the Operations Manager Trevor Martin who worked tirelessly under difficult circumstances I thank the Trustees of the Club and the Internal Audit Committee for their valuable advice, support, and guidance.

The Club's finances have been well managed during another difficult year under the leadership and guidance of our Honorary Treasurer Nilanka Pieris. My sincere thanks to Nilanka for his very willing advice and unwavering support and commitment to the affairs of the Club.

To the Honorary Assistant Secretary Mr. Mahinda Halangoda and all my colleagues on the Executive Committee, a big thank you for extending your unstinted support and cooperation, to Mr. W. T. Ellawala for many years of great exemplary leadership and guidance and to our new President Mr. I. S. De Silva for his able stewardship.

TREASURER'S REPORT – 2021

I have great pleasure in presenting the Treasurer's Report for the year ended 2021.

The financial performance of the club continued to be impacted by Covid-19 during the year under review. The club managed to record an improved net profit of Rs 5,788,261 when compared to a net profit of Rs. 4,102,161 recorded in the year 2020. The Total Assets of the club at the end of the financial year stood at Rs. 507,012,356 which is an increase of Rs. 7,730,224 over the previous year. The club continued to maintain a very healthy cash position of Rs. 86,921,679 which consisted of a Wealth Management Account balance of Rs.63,222,774, Cash at Bank (Current & Savings) balance of Rs.21,418,176 and Cash in Hand balance of Rs.2,280,729. During the year, a sum of Rs. 36,350,857 was invested to improve the infrastructure of the club.

The club witnessed an increase of Rs. 10,484,049 in Income and Rs. 3,196,201 in Direct Expenses when compared to the previous financial year. The increase in the income was mainly due to the relaxation of certain health restrictions that were in place during the previous financial year. Careful management of our overheads together with a reduction in non-urgent expenditure resulted in an Operating Profit of Rs. 65,377,440 which was an increase of Rs. 7,287,848 when compared to the previous year.

The Bar and Restaurant recorded losses of Rs. 5,745,181 and Rs. 10,741,552 respectively. Our inability to host the annual school big matches with spectators and the closure of the club for a couple of weeks impacted our revenue from the Bar and Restaurant. Increased cost of goods sold also contributed significantly to the reduced operating profit in the Bar. The Restaurant on the other hand managed to reduce the loss when compared to the previous year through the implementation of a streamlined purchasing policy.

Interest Income reduced by Rs. 1,532,938 due to a very low yield from our interest bearing assets. Interest rates are expected to rise in the future and thereby increase our interest income.

Renewed interest by new members to join the club when compared to the previous year resulted in Entrance Fess increasing by 10,291,63. Significant savings from the implementation of Phase 2 of the Solar Power system was realized and the club managed to earn a sum of Rs. 333,089 through the sale of the excess production during the period the club was closed.

I would like to place on record my sincere appreciation to our dynamic Honorary Secretary Mr Vasantha Wijesekera for his dedication and commitment towards the management of the club.

I also would like to extend a word of appreciation to my Honorary Assistant Treasurer – Mr Suren Goonewardena, the President and Executive Committee members, the staff of the club, Ernst & Young for the Financial Accounting services and KPMG for carrying out duties as the clubs Auditors.

1. DOMESTIC CRICKET

The domestic season was curtailed to only the Premier Limited Over tournament due to the Pandemic even though Sri Lankan Cricket had a new tournament structure in place.

The Premier Limited Over tournament which was the only tournament held this season was held during the Monsoon season in October & November 2021 and due to inclement weather, we were able to play only 3 matches of a maximum of 10 matches where we were able to win two and lose one match while the rest of the matches ended as no result.

TOURNAMENT PERFORMANCE REVIEW

The season was curtailed to only the Premier Limited Over tournament as stated above and there were no significant performances to highlight due to only three games being completed the whole of last season

SSC SCHOOL OF CRICKET

The year 2021 was a mixed bag for all the youngsters of the SSC School of Cricket, in terms of the Pandemic and cricket. The students were able to attend cricket practices sporadically and also participate in a few tournaments that was conducted during the period. Even though the first few

months of the year until April permitted the youngsters to attend practices, the months of May, June, July and August were not permitted due to the spread of Covid19 and the increase in the spread, thus resulting in students not attending. The Cricket House Committee and the Executive Committee in conjunction made contact with the Health and Sports Ministry and under strict disciplines and health guidelines, we were able to once again conduct practices for the Cricket School. The youngsters started trickling in once again and the attendance improved greatly. At this point I wish to make specific mention that the parents and senior players need to be praised for their utmost support towards the SSC Cricket School and for payment of fees.

Just to recap on this year's progress, we ended up U15 Runner-up in the Colombo Premier Cricket Foundation Tournament that was conducted in March 2021. The SSC Under 15 Blue Team captained by Akash Karunanayake and Vishen Halambage, as its Vice Captain ended up as Runner-Up to CCC due to bad weather, thus losing on the Parabola system. The best performers with the bat were Akash Karunanayake, Vishen Halambage and Thenushka Nanayakkara and Vishal Rukshan. In the bowling department yet again Vishen Halambage and Thenushka Nanayakkara excelled, along with performances from Kemila Govinda, Yatindra Siriwardena, Vishal Rukshan and Shaun Roberts. Thenushka Nanayakkara was adjudged as the best bowler of the tournament with 21 wickets. Vishen Halambage was the highest scorer for us with 205 runs.

The U13 SSC Blue team ended runner-up in the Under 13 Colombo Premier Cricket Foundation Tournament that was just conducted in the month of December 2021.

In the U15 category 50 Over Colombo Premier Cricket Foundation Tournament conducted in November-December 2021, we won all the 1st round matches but failed to live up to the level of competitiveness during the knockout stage.

In the Freedom Tournament, we competed quite well but not fierce enough to come to the final round. In most matches at U15 level, players were unable to attend due to District Selection and U13 level due to School practices and selections that were arranged on match days.

Also with a sense of obligation, I wish to reiterate that many a player got the opportunity to participate in teams that participated in the U13 and U15 category this year, giving almost all an opportunity to play competitive cricket due to the massive dearth of cricket at age group level. It may be mentioned that personally, I ensured that talented cricketers of the SSC School of Cricket faced the trials and matches at District level and happy to indicate they have gained selection to squads.

HONORARY GROUND SECRETARY'S REPORT 2021

Unlike the previous year, the ground was used throughout the year, except in May when several matches were cancelled due to health restrictions imposed by the Govt due to Covid 19. The ground was also closed mid-December for repairs. The matches played, were without spectators.

We were fortunate that SLC used the club practice facilities and the grounds extensively, which negated the cancellations/postponement of scheduled matches during the year.

The club T20 and limited over matches were played concurrently in March and April. The Final of the limited over was also played at the SSC on the 11th of April.

The Indian and South African national teams used SSC's facilities in July and August prior to their matches against the Sri Lankan team. The West Indies team played a 4-day practice match against the Board XI in November while the England U19 played 5 ODI matches against the Sri Lanka U19 team in November/December 21'.

The Royal-Thomian and Joe-Pete big matches were played in October and December respectively sans any spectators. These two matches had initially been scheduled to be played in March, but were postponed due to the Covid 19 pandemic. Both matches ended in draws while the Royal-Thomian match hardly had any play due to heavy rain throughout the match.

All these matches were played with the ground staff being kept in a bio-bubble in the club to prevent the spread of the virus. The club has not recorded any players being infected with the Covid 19 virus after playing at SSC largely in most part due to the outstanding health protocols followed by the club management and strictly adhered to by the staff.

During periods when the ground was not utilized the ground staff did manual weeding as well as weedicide to remove weed patches in the outfield and transplanted them with blue grass.

The Club was able to secure an outfield cutter courtesy of Sri Lanka Cricket (SLC), which was long overdue. This Toro machine was imported from the USA and will serve the club for many years to come. The previous cutter (over 15 years old) will be refurbished and kept as a backup. SLC also donated two pitch covers to the club. The Club purchased a much-needed Allett C-20 grass-cutting machine with accessories which will enable us to prepare much better wickets in the future. Currently, SSC is the only club to possess this machine.



During the period under review the SSC management decided to renovate the ground staff quarters. Space has also been added for the storage of equipment. A new dugout was constructed in front of the SLC main office enabling the players to use it during matches. In addition, the indoor nets, side screen and the drain around the grounds were repaired. Most of these repairs were done in-house to limit expenses.

Singer Sri Lanka agreed to upgrade the scoreboard to an electronic one while keeping the old scoreboard appearance. The new scoreboard which is currently in operation will be managed by the scorer and will eliminate the need for 12+ ground staff members to operate it thus, freeing them to work on the side wickets and other areas during match days. The Club ordered special ground covers, which will help staff to cover the pitches quickly with minimum numbers (light covers) while keeping the wickets fresh even if the ground is covered for long periods due to wet weather. These covers should arrive in Sri Lanka by May 22'.



The Curator was given a further contract as it was determined he required more time to adjust to the role he was appointed. The ground staff headed by Kamal and his assistant Chamila did a commendable job last year and this was confirmed by the reports given by the match referees soon after matches played at the SSC.

I would like to take this opportunity to thank the ground staff for the tremendous work done during the past year and hope they will continue to support with the same vigor this year as well.

My sincere gratitude to Sri Lanka Cricket for hiring the grounds, extending monetary support towards purchasing of machinery and maintenance of the grounds during the period under review. Their support has certainly helped us to ensure we have one of the best grounds in Sri Lanka.

I also wish to thank the Club President, Executive Committee and Office Bearers for their continued support towards ground development.

EXECUTIVE SUMMARY

The SSC Tennis House Committee (the THC) had one of the most successful years in recent times 2021. Despite several challenges, including the pandemic and several start stops to play during the year, the THC was able to record several achievements, including hosting the two national level events, the SSC Open 2021 and the Tennis Tens 2021 and the International Wheel Chair Tennis Tournament 2021 with much success. Whilst key sponsors continued to support the events, THC also secured a three-year sponsorship 2022 – 2024 with one of the leading financial institutions in the country. THC Members continued to contribute both at the national and international levels, including at the Olympic Games (Media Team, Tokyo 2020), the International Tennis Federation - Worldwide Coaches Conference and representation at the National Davis Cup and Fed Cup teams. An exceptional achievement was recorded with the Number One National Rankings in Ladies and Gentlemen's Singles and Doubles being secured by SSC THC Members capping of a remarkably successful Year.

Report

1) SSC Open Tennis Championships 2021

The SSC Open 2021 was the first national level competition conducted for the year. There were over 800 entries received for the events including Juniors, Open and Senior Singles and Doubles events including a Mix-Doubles event which was conducted for the first time in a few years.

The SSC Open 2021 Women's Champion was Miss Savini Jayasuriya winning her first title at the SSC Open by overcoming her close friend and doubles partner Ms Janali Manamperi. In the the Men's Champion match next gen players were featured, with Mr Luca Knese overcoming Mr Vibuda Wijebandara in a hard fought three setter.

The Prizegiving of the SSC Open Tennis Tournament was attended by several distinguished guests including Mr Dilshan Wirasekara, CEO, First Capital Holdings Plc, Mr Yohan Thilakaratne, DIMO Sri Lanka, Mr Suriya Bibile, Director, 3 G Sports, Mr Vasantha Wijesekera, Honourary Secretary of SSC, and Mr Neshan Gunasekera, Chairperson of the SSC Tennis House Committee. Also, Mrs Amritha Malawikankanamge and Mr Arjun Fernando, two outstanding former national champions graced the occasions of the two finals. It is noted here with appreciation the services rendered by our Tournament Director, Mr. Chammika De Silva, the THC Organizing Committee, Mr Mufaddal Hazari, the Referee (also SSC Member), the Ground Staff, the Office staff especially, the General Manager Chari, and office staff Niluka and Priyanthi.

Further, the Ladies and Gentlemen's Finals were streamed online for the first time with the support of *Papare.com* which was a historic occasion for both the SSC and Sri Lanka. This was the first time a premier event in Sri Lanka was live streamed and it was supported by an expert group of commentators led by Mr Aruna Seneviratne, former SSC Captain, National Player and current Selector with Mr Guyanga Weerasekera and Mr Nishendiran Sivendran. The ground staff, Mr Raja, Indika and Kiruba were felicitated during this event.

2) **12th SSC Open - International Wheelchair Tennis Tournament 2021**

SSC THC conducted the 12th Annual SSC OPEN International Wheelchair Tournament from 30 March – 1 April 2021. The two top seeds met in the Finals of each of the events, Mens Singles and Doubles. In the Singles, Mr S. Dharmasena overcame Mr G. Dissanayake, whilst in the doubles, Mr G. Dissanayake along with his partner Mr Pradeep Kumara overcame the top seeds, Mr S Dharmasena and Mr RL. Ranaweera in three long sets.

The hosting of these international events, despite the pandemic enabled national players to secure critical international ranking points, which enabled Mr S.R. Dharmasena to secure an invitation to the Tokyo Paralympic Games 2020.

3) **SSC Tennis Tens 2021**

The SSC Tennis Tens event was conducted successfully with a large number of ten and under players participating in the Girls and Boys, under 10, 9 and 8 age groups categories. However, the pandemic and schools being closed affected the overall conduct of the tournament.

4) **Mr Renouk Wijemanne - appointed as Head Coach of the High Performance Programme at SLTA**

It was informed that Mr Renouk Wijemanne was appointed as the Head Coach of the High Performance Programme of the Sri Lanka Tennis Association in July 2021. Whilst congratulating Mr Wijemanne, the Chairperson invited him to share some further background to this programme.

Mr Wijemanne, whilst thanking everyone, provided an overview of the High Performance Programme. It was a 5 Year plan, incorporating 32 players within the Under 16, 18 (Girls and Boys), Womens and Mens categories with a view to producing international level (ITF, Asian Games, SAF) results within the next few years. Mr Wijemanne also mentioned that it was an honour to be appointed as Head Coach of the National Programme

5) **SSC Members represent Sri Lanka at the Davis Cup 2021**

SSC THC Member Mr Renouk Wijemanne was the non-playing Captain of the National Davis Cup team. The team comprised, several SSC Members, including, Mr Thehan Wijemanne, and Mr Chathurya Nilaweera, who was representing Sri Lanka for the first time.

The SSC THC was immensely proud of her achievement as a trailblazers and invited her to a special discussion with the THC upon her return to Sri Lanka.



8) Mr Aruna Seneviratne and Mr Arjun Fernando continued as Tennis National Selectors

SSC THC Members Mr Aruna Seneviratne and Mr Arjun Fernando continued to render their services as National Team Selectors.

9) Mr Guyanga Weerasekera speaks at the ITF World Coaches Conference 2021

Mr Guyanga Weerasekera, SSC THC Member, represented Sri Lanka at the ITF World Coaches Conference (which is the most prestigious coaches conference hosted by the ITF). Mr Weerasekera made a presentation on the subject *Business, Management and Leadership* at this Conference which was well received by an international audience representing many key stakeholders involved with the sport of tennis at the global level.

10) Securing a three (3) year sponsorship for SSC Open and other events with First Capital Holdings PLC

As one of the key achievements of the Year, the THC secured a three-year sponsorship with leading

financial institution, the First Capital Holdings Plcs. Subsequent to being satisfied of the standards at which the SSC THC was hosting its annual event, the SSC Open, First Capital was happy to enter into a three-year partnership. Especially, given the difficult financial situation facing the wider sporting community, this sponsorship is both timely and valuable to game of tennis as most of the key players, officials and administrators are involved with the SSC Open.

A special note of appreciation is recorded of the valuable contribution and leadership taken by Mr Nishendiran Sivendran, THC Assistant Secretary for pursuing and negotiating this partnership.

11) SSC Members dominate the National Ladies and Gentlemen's Rankings Board in 2021

Whilst SSC Members continued to dominate the national tennis circuit and represented all of the national teams at international competitions this year, it was unique feat that SSC Tennis House Members were top ranked at the Year end ranking. Ms Savini Jayasuriya was Ladies Singles Number One in the Country, whilst Mr Thehan Wijemanne was the top ranked player in the Gents. Further, Ms Jayasuriya along with her partner Ms Janali Manamperi, also SSC Member, were the top ranked players in the Ladies Doubles and are also the current National Women's Doubles Champions.

On behalf of the THC, I take this opportunity to reiterate the appreciation to all sponsors, the SSC Ex-Co, the Ground Staff, SSC Office staff for their continued support and the SSC Tennis House Committee – a team that I have the privilege of being part of and leading.

INDOOR GAMES REPORT

BADMINTON – SQUASH – TABLE TENNIS

2021

2021 was no better than the previous year. Government health protocols and country-wide alert for better part of the year over a new variant of Covid 19 that necessitated a third vaccination brought about yet again, a disturbed civic life. People lost their freedom of movement to a great extent and they were more concerned about their own safety. This situation affected all forms of recreational activities. Indoor games were considered the most vulnerable.

The uncertainties left the two sections Badminton and Squash to curtail their activities. It was not possible to have the 2021 Open Championships of both Badminton and Squash. Over the years, these two Championships were the events that injected the necessary funds to the two sections to bridge the gap between Income and Expenditure. The income generated by member patronage, guests income and court hire that significantly dropped was barely sufficient to meet the maintenance and overhead costs. There were additional costs incurred by Covid19 safety measures.

Badminton:

Some of the proposed improvements to the premises such as repainting the entire building, change of lighting system and refurbishment of the toilets were kept on hold. As a result of the schools intermittent closure, at times for long periods, the regular school bookings too were lost. There were the club closures from time to time. Cumulative result at year end was an operational loss.



Squash:

It was the same fate for Squash as for Badminton. However, through a mutual agreement with Sri Lanka Squash Federation (SLS) we were able to sustain the Squash Division and meet its operational expenses to a great extent. SSC courts hosted almost all SLS tournaments during the year, at times under special permission granted to SLS by the Health Authorities; namely the 40th National Squash Championship and Under 11 Age Group Category in January, Open Junior Championship in March, Guardians Open in May, Prima Stella Junior Open in November, 32nd Junior Nationals in December. The Club's A/C Pavilion was the venue for all the Award Ceremonies that brought in substantial revenue to the club.

Ravindu Laksiri the current and national Men's Champion for 8 years was granted one year playing membership at SSC. He will be carrying SSC identity at all local tournaments.

Table Tennis:

Table Tennis Section formally declared open in January with three WTTTF approved quality tables is gaining popularity. A TT Academy run by a former National Champion and a qualified coach operates during weekends.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1.1 General Policies

1.1.1 Basis of Preparation

The Statement of Financial Position, Income Statement, Statement of Changes in Equity, Statement of Cash Flows ,and notes together with summary of significant accounting policies (the “Financial Statements”) of the club have been prepared in accordance with Sri Lanka Accounting Standard for Small and Medium – sized Entities as issued by The Institute of Chartered Accountants of Sri Lanka (ICASL).

1.1.2 Responsibility for Financial Statements.

The Executive Committee of Singhalese Sports Club is responsible for the preparation and fair presentation of financial statements.

1.2 Significant Accounting Judgments, Estimates & Assumptions

The preparation of the Club’s Financial Statements requires management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities and the disclosure of contingent liabilities, at the reporting date. However, uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amount of the asset or liability affected in the future. These factors could include judgment, estimates and assumptions.

Judgments

In the process of applying the club's accounting policies, management has made some judgments, apart from those involving estimations and assumptions, which have the most significant effect on the amounts recognized in the financial statements.

Estimates & Assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

1.2 Significant Accounting Judgments, Estimates & Assumptions (Cont ' d)

(a). Fair Value of Financial Instruments

Where the fair values of financial assets and financial liabilities recorded on the Statement of Financial Position cannot be derived from active markets, they are determined using a variety of valuation techniques that include the use of discounted cash flows model and/or mathematical models. The inputs to these models are derived from observable market data where possible, but where observable market data are not available, judgment is required to establish fair values.

Changes in assumptions about these factors could affect the reported fair value of financial instruments.

(b). Valuation of Defined Benefit Obligations

The cost of defined benefit pension plans is determined using the half a month's salary of the last month of the financial year in respect of all employees who have had five years of service, commencing from the first year of service.

(c). Fair Value

Fair value is the amount of consideration that would be agreed upon in an arm's length transaction between knowledgeable, willing parties who are under no compulsion to act. When a financial instrument is initially recognized, its fair value is generally the value of the consideration paid or received. Subsequent to initial recognition, the fair value of a financial asset quoted in an active market is generally the bid price and, for a financial liability quoted in an active market, the fair value is generally the asked price. For financial instruments such as cash equivalents and short- term investments that have a short duration, the carrying value of these instruments approximates fair value.

(d). Income Tax

The club is subject to income taxes and significant judgment is required in determining the overall provision for income taxes.

1.3 Functional & Presentation Currency

The functional currency of the club is determined to be Sri Lanka Rupees and the Financial Statements are also presented in Sri Lanka Rupees.

2. SPECIFIC ACCOUNTING POLICIES

2.1 Financial Assets

The club classifies its financial assets into the following categories; held to maturity, available for sale and trade receivables. The classification is determined by management at initial recognition and depends on the purpose for which the investments were acquired.

2.1.1 Classification

(a). Held-to-Maturity Financial Assets

Held-to-maturity investments are non-derivative financial assets with fixed or determinable payments and fixed maturities that the club's management has the positive intention and ability to hold to maturity, other than: those that;

The club upon initial recognition designates as at fair value through profit or loss; or

The club designates as available for sale; and

That meets the definition of loans and receivables.

Interests on held-to-maturity investments are included in the income statement and are reported as 'Other Income'.

(b). Available-for-Sale Financial Assets

Available-for-sale investments are financial assets that are intended to be held for an indefinite period of time, which may be sold in response to needs for liquidity or changes in interest rates, exchange rates or equity prices or that are not classified as loans and receivables, held-to-maturity investments or financial assets at fair value through profit or loss.

(c). Trade Receivables

Trade Receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Receivables arising from ordinary transactions are also classified in this category and are reviewed for impairment.

2.1.2 Recognition & Measurement

Financial assets are initially recognized at fair value plus, in the case of all financial assets not carried at fair value through profit or loss, transaction costs that are directly attributable to their acquisition. Financial assets carried at fair value through profit or losses are initially recognized at fair value, and transaction costs are expensed in the income statement. Financial assets are derecognized when the rights to receive cash flows from them have expired or where they have been transferred and the club has also transferred substantially all risks and rewards of ownership. Available-for-sale financial assets are subsequently carried at fair value. Trade receivables and held-to-maturity financial assets are carried at amortized cost using the effective interest method.

Changes in the fair value of monetary and non-monetary securities classified as available for sale are recognized in other comprehensive income.

When securities classified as available for sale are sold or impaired, the accumulated fair value adjustments recognized in other comprehensive income are included in the income statement as net realized gains/losses on financial assets.

Interest on available-for-sale securities calculated using the effective interest method is recognized in the income statement.

2.1.3 Determination of Fair Value

The fair value of loans and advances as well as liabilities to banks and customers are determined using a present value model on the basis of contractually agreed cash flows, taking into account credit quality, liquidity and costs.

The carrying value less impairment provision of trade receivables and payables are assumed to approximate their fair values.

2.1.4 De - Recognition

A financial asset (or, where applicable a part of a financial asset or part of a Group of similar financial assets) is derecognized when:

The rights to receive cash flows from the asset have expired.

The Club has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and either.

2.1.4 De - Recognition (Cont'd)

- (a) The Club has transferred substantially all the risks and rewards of the asset, or
- (b) The Club has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Club has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, and has neither transferred nor retained substantially all of the risks and rewards of the asset nor transferred control of it, the asset is recognized to the extent of the Club's continuing involvement in it. In that case, the Club also recognizes an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Club has retained. Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Club could be required to repay.

2.1.5 Taxation

Current Taxes

The provision for Income Tax is based on the elements of Income & Expenditure as reported in the financial statements and computed in accordance with the provisions of the Inland Revenue Act No. 24 of 2017 and the amendments thereto.

2.1.6 Borrowing Costs

Borrowing costs that are directly attributable to acquisition, construction or production of qualifying assets, which takes substantial period of time to get ready for its intended use or sale, are recognized as expenses in the period in which they are incurred and charged to the Statement of Comprehensive Income.

2.2 Valuation of Assets & their Measurement Bases

2.2.1 Inventories

Inventories are valued at the lower of cost and net realizable value, after making due allowances for obsolete and slow moving items. Net realizable value is the price at which inventories can be sold in the ordinary course of business less the estimated cost of completion and the estimated cost necessary to make the sale.

2.2.2 Cash & Cash Equivalents

Cash and cash equivalents are defined as cash in hand, demand deposits and short-term highly liquid investments, readily convertible to known amounts of cash and subject to insignificant risk of changes in value.

For the purpose of cash flow statement, cash and cash equivalents consist of cash in hand and deposits in banks net of outstanding bank overdrafts. Investments with short maturities i.e. three months or less from the date of acquisitions are also treated as cash equivalents.

2.2.3 Property, Plant & Equipment

(a). Cost / Revaluation

Property and equipment, including owner-occupied property, is stated at cost, excluding the costs of day-to-day servicing, less accumulated depreciation and accumulated impairment losses. Replacement or major inspection costs are capitalized when incurred and if it is probable that future economic benefits associated with the item will flow to the entity and the cost of the item can be measured reliably.

The cost of property and equipment is the cost of acquisition or construction together with any expenses incurred in bringing the asset to its condition for its intended use. Where items of property and equipment are subsequently re-valued, the entire class of such assets is re-valued.

When an asset is re-valued, any increase in the carrying amount is credited directly to a revaluation reserve, except to the extent that it reverses a revaluation decrease of the same asset previously recognized in the income statement, in which case the increase is recognized in the income statement. Any revaluation deficit that offsets a previous surplus in the same asset is directly offset against the surplus in the revaluation reserve and any excess recognized as an expense. Upon disposal, any revaluation reserve relating to the asset sold is transferred to retained earnings.

2.2.3 Property, Plant & Equipment (Cont ' d)

(b). Depreciation

The provision for depreciation is calculated by using straight line basis on the cost or valuation of all Property, Plant and Equipment; in order to write off such amounts over the following estimated useful lives. The principal annual rates used are:

Buildings, Swimming Pool & Badminton Complex	Over 40 years @ 2.5%
Furniture & Fittings, Plant & Machinery	Over 10 years @ 10%
Motor Vehicles	Over 6.6 years @ 15%
Computer Equipment, Gym Equipment & Children's Play Equipment	Over 05 years @ 20%
Restaurant Utilities, Bar Utilities & Bar/Restaurant System	Over 04 years @ 25%
Admin, Restaurant & Kitchen Tools	Over 01 year @ 100%

Depreciation of an asset begins when it is available for use as determined by the management and depreciation of an asset ceases at the earlier of the date that the asset is classified as held for disposal and the date that the asset is derecognized.

(c). Impairment of Assets

The carrying amount of the Club's asset is reviewed at each reporting date to determine whether there is, any indication of impairment. If any such indications exist then the assets recoverable amount is estimated.

An impairment loss is recognized if the carrying amount of an asset or its cash generating unit exceeds its recoverable amount. A cash generating unit is the smallest identifiable asset group that generates cash flows that are largely independent from other assets and Clubs impairment losses are recognized in income statement.

The recoverable amount of an asset or cash generating unit is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of the time value of money and the risk specific to the asset.

2.2.3 Property, Plant & Equipment (Cont ' d)

(d). Impairment of Assets

Impairment losses in respect of assets other than goodwill recognized in prior periods are assessed at each reporting date for any indications that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the assets' carrying amount does not exceed the carrying amount that would have been determined net of depreciation or amortization if no impairment loss had been recognized.

2.3 Liabilities & Provisions

All known liabilities have been accounted for in preparing the financial statements.

2.3.1 Retirement Benefit Obligations

(a) Defined Benefit Plan - Gratuity

Gratuity is a Defined Benefit Plan. In order to meet this liability, a provision is carried forward in the Statement of Financial Position, based on a half a month's salary of the last month of the financial year in respect of all employees who have had five years of service, commencing from the first year of service.

(b) Defined Contribution Plans-Employees' Provident Fund & Employees' Trust Fund

Employees are eligible for Employees' Provident Fund Contributions and Employees' Trust Fund Contributions in accordance with the respective Statutes and Regulations.

2.4 Capital Grants

Grants are related to assets. These grants have been deferred in the Statement of Financial Position and credited to the Comprehensive Income over the useful life of the related assets. Donations received to meet expenses in a given year are accounted for on receipt basis.

2.5 Comprehensive Income

2.5.1 Revenue Recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Club and the revenue and associated costs incurred or to be incurred can be reliably measured. The following specific criteria are used for the purpose of recognition of revenue.

(a) **Sale of Goods**

Revenue from sale of goods in the Bar and Restaurant is recognized when the significant risks and rewards of ownership of the goods have been passed to the buyer.

(b) **Rendering of Services**

Revenue from rendering of services is recognized on an accrual basis.

(c) **Interest**

Interest income is recognized on an accrual basis.

(d) **Rental Income**

Rental income is recognized on an accrual basis.

(e) **Membership/ Subscription Income**

Membership / Subscription income is “recognized on an accrual basis”.

(f) **Other Income**

Other Income is recognized on an accrual Basis

Net gains and losses of a revenue nature on the disposal of Property, Plant & Equipment and other noncurrent assets including investments have been accounted for in the Statement of Comprehensive Income, having deducted from proceeds on disposal, the carrying amount of the assets and related selling expenses. On disposal of revalued Property, Plant and Equipment, amount remaining in the Revaluation Reserve relating to that asset is transferred directly to income over expenditure.

2.5.2 Expenditure Recognition

Expenses are recognized in the Statement of Comprehensive Income on the basis of a direct association between the cost incurred and the earning of specific items of income. All expenditure incurred in the running of the business and in maintaining the Property, Plant & Equipment in a state of efficiency has been charged to income in arriving at the income over expenditure for the year.

2.6 Leases

Payments made under operating leases are recognised in profit or loss on a straight-line basis over the term of the lease. Lease incentives received are recognised as an integral part of the total lease expense, over the term of the lease.

Minimum lease payments made under finance leases are apportioned between the finance expense and the reduction of the outstanding liability. The finance expense is allocated to each period during the lease term so as to produce a constant periodic rate of interest on the remaining balance of the liability.


